Commencement of Meeting:

Meeting declared open by RK at 8.00pm. RK welcomed the Committee and other club members attending and thanked everyone for taking the time out to participate. PJ arrived at 8.15pm

Minutes of 2022 AGM dated 7th November 2022. Accepted as a true record of proceedings.

Presidents Report / Coaching Coordinator's Report:

RK presented the President / Coaching Coordinator Report (refer attached). Highlights were discussed:

Since last year's increase in tempo after 2 years of restrictions, we have continued to build on our momentum, with highlights as follows:

- No increase in club training fees this year. Thanks to Kate Peake, having taken over the membership coordination role, for making great progress to manage member club training fees and Judo NSW financial currency for our members.
- Restructure of compensation payable to our coaches for their direct expenses whilst maintaining volunteer status. We have also had a number of new young support coaches (returning athletes) which is great and we are trying hard to incentivize more support coaches and over time, to guide them to take on greater responsibility.
- Our first comprehensive awards night in two years; such a great event. Thanks to Carlo and Pizza Alfresco for his support. We also held a hugely successful Christmas party at Ryde Aquatic Centre with over 250 attending, all having a great time this will be a staple item on our future calendar.
- Further progress with grant applications and club building and equipment improvement thanks to Scott Young
- Our first club-hosted NSW Mons/Juniors competition in two years.
- A strong National representation at National training camps, at international competitions across Cadet and Senior categories, and at weekly NSW National Hub sessions. Participation/performance in international competition increased significantly this year. Sydney and ACT Opens had huge increases in participation, Nationals was on par with 2022 but Melbourne and Gold Coast were well down in numbers which was disappointing. We still have a solid Kata following.
- We can expect \$50 increases in Judo NSW annual membership fees commencing November 2023, with the new Junior (U/16yo) fee \$150 and Seniors (16yo+) \$190. Judo NSW is also introducing a new volunteer requirement on clubs to support NSW competitions which will require some energy and resources.
- This time last year our membership sat at 208 and this year has seen a very stable membership overall, constantly around 200 which it is at the time of writing. Interest is generated from referrals from club parents

- and members, from our website, facebook Instagram and external sites like "Kidsbook". Retention is still healthy, and attendance at all 9 weekly classes is still strong.
- Athlete support and services remain high with sponsorship of coaches and athletes to the Nationals increasing from \$4800 in 2022 by over 50% to \$7400. We also support athletes competing internationally, provide free club training to National Development Squad members and we also sponsor these athletes through provision of strength and conditioning programming/training.

RK also recorded a note of thanks to all coaches and all committee members for their dedication to the club. Motion to accept the report as follows:
