RISK WARNING

Judo is a recreational activity that involves an obvious, significant and inherent risk of physical harm. It is a contact sport that involves the use of throwing techniques that can, and sometimes do, cause physical injury to the person being thrown or to the person performing the throw. It also involves techniques for holding persons down, arm bars and strangulations, notwithstanding age restrictions for application of strangulations (Cadets and older) and arm bars (Junior Men/Women and older). All of these techniques involve obvious, significant and inherent risks of causing physical injury.

When you decide to participate in the sport of Judo you are doing so knowing the significant risk of physical harm that you could sustain.

YOUR AGREEMENT WAIVER OF CLAIMS

By signing this document you agree that it is an essential term of the Budokan Judo Club Incorporated and its officers, servants agents or instructors, accepting of you, your child or the person or child for whom you are legally responsible as:

- (i) a member, or
- (ii) a temporary member, or
- (iii) a visitor

and providing their permission for you, your child or the person or child for whom you are legally responsible to engage in its Judo classes, that you agree on your own behalf or on behalf of any of your children or any children or persons for whom you are legally responsible for, to waive, release and forever abandon all claims that you might otherwise have against Budokan Judo Club Incorporated and/or any of its officers, servants, agents or instructors that might arise now or at any time in the future out of or as a consequence of any injury you, your child or the person or child for whom you are legally responsible, might sustain from playing Judo and/or participating in classes at the Budokan Judo Club Incorporated.

By signing this document you are further acknowledging and accepting that your participation and engagement, or that of your child or the person or child for whom you are legally responsible, in the sport of Judo at the Budokan Judo Club Incorporated is at your own risk or the own risk of your child, or of the person or child for whom you are legally responsible and involves the risks set out in the Risk Warning above.

It is also expressly acknowledged and agreed by you that this waiver by you of your rights or the rights of your child or a child or person for whom you are legally responsible, shall extend to and include all claims whether arising out of contract or out of an allegation of any negligence against Budokan Judo Club Incorporated and/or any of its officers, servants, agents or instructors.

CHILDREN

Where the participant in Judo at the Budokan Judo Club Incorporated is a person under the age of 18, or otherwise affected by a legal disability affecting that persons capacity to enter into a contract, you are acknowledging by signing this document that each such child or person:

- (i) is under your control, and;
- (ii) that you have read and understood the above Risk Warning on behalf of that child or person and;
- (iii) that you agree that the above waiver applies to any participation by each such child or person at the Budokan Judo Club Incorporated;

The above Risk Warning is given by Budokan Judo Club Incorporated on its own behalf and on behalf of all of its officers, servants, agents and instructors.

Budokan Judo Club Incorporated relies on the Risk Warning and on the Waiver as an essential condition to its acceptance and its agreement to the child or person named below participating in the sport of Judo at its Club.

The Waiver is given to Budokan Judo Club Incorporated itself, its officers, servants and agents and to Budokan Judo Club Incorporated as the agent and representative of each and every Judo instructor at Budokan Judo Club Incorporated, now, in the past or in the future.

Each instructor relies upon the Risk Warning and the Waiver in agreeing to instruct and supervise the signatory or the signatory's child in the sport of Judo.

Each parent or legal guardian signing this document agrees to indemnify Budokan Judo Club Incorporated, its officers, servants and agents and each of its instructors against any liability, loss or expense arising from any claim that might be brought by the child or person named below against Budokan Judo Club Incorporated, its officers, servants or agents and/or any of its instructors.
